- (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tasildhar and
- (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
