

The extra cost incurred by AIAHL in executing such work(s) through other agency /agencies along with a penalty up to a maximum of 10% of the cost of the work will be recovered from the bills/ security deposit of the contractor.
26. The contractor to use the material, as specified in CPWD DSR 2023 (w.e.f. 16.10.2023) for execution of various items of civil works, The material not covered in CPWD DSR 2023 (w.e.f. 16.10.2023) for execution of various items as approved by AIAHL.
27. Workmen's Compensation Policy: Contractor to cover his workmen under Workmen's Compensation Policy. The Workmen's Compensation Policy shall cover the period of contract and defect liability period.
28. The rates of all items include material cost, labour cost, plant & machinery, tools, all appliances including safety harnesses etc. whatsoever necessary for complete execution of the work.
29. Commencement of Contract: The successful tenderer after completing the required formalities, should commence the service within 12 days from the date of issue of the work order.
30. Payment of Bills: Contractor is required to submit the bill in duplicate, along with measurements within one month of completion of the work. The payment to the contractor will be made after certification of the bill by the engineering dept. subject to joint verification of quantities accounted

in the bill and all relevant papers attached.

31. Indemnification:

- a) The Contractor shall indemnify AIAHL against any claims, damages, loss or penalty including costs thereof, in case of liability arising out of any accident/incident involving manpower deployed by him.
- b) The Contractor shall also indemnify AIAHL against any claims, damages, loss or penalty including cost thereof, arising out of any breach or violation of any Govt. levies, terms & conditions of the contract and of the provisions of all the laws, including labour laws as applicable.

32. Termination Clause:

- a) In case the performance of the Contractor is found unsatisfactory for any reason, the contract will be terminated by AIAHL by giving one-month advance notice to the contractor.
- b) If, the contractor intends to terminate the contract/agreement, he may do so, by giving three months' notice in advance, in writing to AIAHL.

33. Extension of Agreement: The successful Tenderer shall execute an agreement with AIAHL on non-judicial stamp paper of Rs. 100/-. The agreement shall be for the scope of work, rates, terms & conditions as per the tender. The contract shall be for a period of 12 (Twelve) months and may be further extended for another period of (24) Twelve months on yearly basis, with mutual consent of both the parties, on same rates, terms & conditions, subject to satisfactory performance of the contractor.

34. Safety Compliances: The contractor shall comply with all safety regulations as per good industry practices and prevailing laws and regulations at the workplace.

35. Settlement of Disputes: Any dispute or differences, whatsoever arising between the parties, out of or relating to the scope of the work, interpretation, application, meaning or effect of this contract or the validity or the breach thereof, shall be referred for settlement to "SCOPE FORUM OF COUNCILIATION AND ARBITRATION" GOVT. OF INDIA and the award made in pursuance thereof, shall be binding the parties to the arbitration. Any dispute whatsoever shall be subject to the Jurisdiction of New Delhi Courts only.
