AI Assets Holding Limited is looking for Chief Executive Officer for its subsidiary, Hotel Corporation of India Limited (HCIL) having its registered office in New Delhi. Hotel Corporation of India Limited (HCIL) was incorporated under the Indian Companies Act, 1956 with the objective to carry on the business of Hotels and Flight Catering Services. HCIL is engaged in providing services in the field of hotel at Delhi. In addition, it provides Inflight Catering Services through its flight catering units at Delhi and Mumbai by the name of Chefair.

Applications are invited from eligible candidates to fill up the post of CEO, HCIL. He will be based in Delhi and would be overall responsible for performance of the Company including that of the Chefair, the Inflight Catering Services unit. He will be on contract for a period of three years extendable by two years based on performance. The tenure can be extended or curtailed as per the requirement of the Company.

The incumbent should be professionally qualified, result oriented with proven leadership qualities and should have been part of the Top Management Team of any Public/Private Sector organization.

The candidate should possess professional qualification viz., MBA OR equivalent Post Graduate Management Degree/Diploma OR Post Graduate Degree/Diploma in Hotel Management.

2. **Age:** 57 years as on the date of notification of advertisement

3. **Experience:** Candidate should have 20 years of Managerial experience out of which at least 05 years of experience at senior managerial level (not more than two levels below CEO/Head of the Institute in Hospitality Sector, preferably in Aviation Sector).

b. **Private Sector**

Private Sector candidates who are working not more than 2 level below CEO/Head of Chain of Hotels/Airlines with minimum average annual turnover of Rs 60 crores during last 03 financial years i.e. 2021-22, 2022-23 & 2023-24 would be considered.
