Terms & Conditions

1. The training institute should be approved by DGCA, the regulatory authority. The proof of authorization should be submitted along with the quotation.
2. DGCA approval for conducting New CBTA Functions should be submitted by the bidder along with quotation.
3. Training Hall, Instructor, Training Aids (Projector/White board/Marker) approved by DGCA will be provided by Selected vendors.
4. The parties should submit documentary evidence to prove that they have authorized trainers & Classrooms for imparting the training as per DGCA guidelines.
5. The empaneled training institutes should submit Month wise schedule of training offered as per their capacity in each functions & preferred Locations.
6. Training should be preferably conducted at Mumbai, Goa, Ahmedabad, Pune & Nagpur. To fulfill the training batch requirement, the very minimum staff can be moved from other stations at one metro location for training purpose on merit basis. However, in case the training institute does not have facility to conduct training at above cities the other location where the facility is available can be considered.
7. The empanelment will be done for 3-5 parties as per available capacity to suit our requirement.
8. **The Training Institute should quote the charges for every single batch of 20 (twenty participants) for different category of training at the particular station according to the requirement.**
9. **In case the institute accommodates AIASL employees in batches for other organization the vacant seats should be offered to AIASL for which payment per candidate on pro rata basis of batch charges will be payable by AIASL**
10. Training Manual/Workbook will be provided by the vendor only.
11. AIASL will utilize the services as per availability of trainers/ Classroom with party. However, AIASL does not guarantee minimum business to individual vendor.

Commercial Terms:

1. **PAYMENT TERMS:** Will be made within 60 days (45 days for MSME) from the date of receipt of the material/original invoice, whichever is later. Request if any, for an earlier payment or payment against delivery or advance payment will not be entertained.
2. **AWARD CRITERIA:** The vendor with L1 rate for each station i.e Mumbai, GOA, Ahmedabad, Pune & Nagpur will be given preference with number of batches as per capacity. Similarly, the vendors with reasonable rates in comparison with L1 rates will also be empaneled & Services may be utilized.
3. **Training Start Date & Completion:** The training in batches should commence as soon as possible (Please specify) from the date of our PO and all batches should be completed within One Year of Period. Kindly submit the training schedule.
4. **PENALTY CLAUSE:** Penalty for the delayed commencement of batches will be charged at the rate of 0.5 % per week subject to a maximum of 10 % of delayed commencement. Similarly, if all the batches are not completed within one year, the penalty @0.5% will be charged per week subject to a maximum of 10 % of batches delayed.
5. The quotation should be inclusive of all applicable taxes, training Material, DG Training Manual and issuance of certificate to participants.
6. The GST rate and amount should be specified separately in terms of percentage and absolute value.
7. AIASL may amend the award quantity +/- 25%. However, there is no guarantee for minimum quantity.
8. You must provide acceptance to AI Airport Services Ltd's Terms and Conditions.
